# PDP 1 focused on:


- 6 existencing Police and Customs Coordination Centres (PCCC's) in Czech Republic – day to day cross-border cooperatin and exchange of police information
- amendment of efective communication and exchange of information among IPCD and PCCC's
- education of CZ police staff dealing with international and cross-border cooperation

# Project Activities

- 1. Educating staff - training, workshops and joint exercises** with the aim to introduce EU instruments/tools of the police, judicial and customs cooperation in the Schengen area
- 2. Working visits to EU authorities and neighbouring countries and welcoming foreign experts in the Czech Republic.**
- 3. Analysis and introduction of standard information technology** for the need to share information and deal with specific cases in order to ensure international police cooperation on central and bilateral level
- 4. Project publicity and management**



# Activity No. 1

## Educating staff - workshops

- **Main topics:**
- Sharing of information (Swedish initiative, implementation of the Prüm decisions, ENFAST, Interpol, Europol, SIS II and SIRENE activities, results about project EPRIS, IMS, overview of information systems of the PCR, etc.)
- Cooperation and collaboration of joint contact centres for police and customs cooperation
- Foreign and asylum agenda (VIS, VISION, Schengen Borders Code, visa consular instructions, newly amended EU asylum legislation, EURODAC, API, re-admission, FADO system, presentation of the work of Frontex agency, Eurosur project, Enter-Exit system etc.)
- Analysis and practical implementation of basic bilateral agreements on police cooperation
- Judicial cooperation - experience with implementation of bilateral and multilateral treaties on judicial cooperation and legal assistance in criminal matters, EUROJUST, EJM, ECRIS, implementation of EU instruments for mutual approval of decisions)
- Enforcing proceeds of crime and customs cooperation within the EU (Neapol II, CIS, FIDE etc.), financial reports – FIU, API, OLAF, CARIN, GRECO etc.



# Activity No. 2


## Working visits

- Get to know how the existing EU instruments are being implemented and are practiced on EU or national level (in neighbouring countries).
- To exchange know how and to establish necessary direct contacts
- the occasion to visit and invite new partners from countries who have newly joined the Schengen area

# Activity No. 3

- **Analysis, SW development and proposal for implementation IS EVIN as possible work-flow system for PCCC in CR**
- This part of the project is connected to the NFM project registered under the number CZ 0005 – Creation of National SIRENE CZ (first calling in framework NFM projects 2004-9)
- SW modification of the system EVIN can aspire to become the standard information technology and (data)base platform for the departments of the Police of the CR dealing with cross-border sharing of information (6 the existing PCCC in CR).
- The project should result in unified infrastructure solution and to standard process for interactive communication between the information systems ETŘ (dominant electronic information system for the Czech Police corps) and EVIN (work flow system for international police cooperation on central level) , thus direct and digital communication interface between Czech and abroad Police authorities
- the acquisition of a new server and client HW features to ensure the operation of IS EVIN
